

**WINDOW AND DOOR
LIMITED WARRANTY SUPPLEMENT
UNITED KINGDOM AND REPUBLIC OF IRELAND**



This Limited Warranty Supplement is additional to and shall form part of the Limited Warranty. This Limited Warranty Supplement applies to Marvin® and Integrity® brand windows and patio doors purchased from a Marvin / Integrity dealer authorized to sell Marvin or Integrity products within the United Kingdom of Great Britain and Northern Ireland and the Republic of Ireland (the "Territory"), and extends to the owner of the structure in which the products are originally installed. This Limited Warranty Supplement is applicable only to product installed in the Territory. THIS LIMITED WARRANTY SUPPLEMENT IS SUBJECT TO AND INCORPORATES THE TERMS, CONDITIONS AND LIMITATIONS SET FORTH IN THE MARVIN LIMITED WARRANTY AND/OR THE INTEGRITY LIMITED WARRANTY, AS AMENDED BELOW, applicable within the United States of America and Canada, and available from your dealer, at <http://www.marvin.com> or <http://www.integritywindows.com>.

WOOD COMPONENTS

The Non-Glass Components section of the Limited Warranty shall exclude wood components. All double-vacuum treated wood components, as well as factory dip-treated mahogany and white oak wood components, sold by a Marvin or Integrity dealer authorized to sell and deliver product within the Territory, are warranted against wood decay for a period of ten (10) years following the original date of purchase. Other wood components are not warranted against wood decay.

EXCLUSIVE REMEDY

If wood decay occurs within the term of this Limited Warranty Supplement, Marvin will, at its option, repair the defect, replace the defective materials, or refund the price paid for the defective materials. Shipping costs, removal, installation, refinishing, and disposal costs and services are not included. Marvin will endeavour to supply original replacement parts; however, replacement parts may differ from the original parts. Replacement parts, including upgrades, are warranted for the remainder of the original product warranty.

LIMITATIONS

Failure to comply with the Limitations set out in this Limited Warranty Supplement shall invalidate the Limited Warranty in respect of wood components. In addition to all terms, conditions, and limitations set forth in the Marvin Limited Warranty or the Integrity Limited Warranty, the following limitations apply:

- Exterior wood must be pre-finished by an authorized Marvin dealer or painted in accordance with Marvin's painting instructions within thirty (30) days of product installation.
- Interior wood must be pre-finished by an authorized Marvin / Integrity dealer or finished in accordance with Marvin's / Integrity's finish instructions within ninety (90) days of product installation.
- If wood is removed from any component after manufacture, a water-repellent preservative containing a minimum of 0.2% Tebuconazol, 0.2%, Propiconazol, and 0.1% IPBC must be applied.
- Adequate and regular inspection and maintenance must be performed.

WOOD DISCOLORATION

Darkening or discoloration of wood components is common throughout the Territory and occurs as a result of moisture exposure and/or fungal growth. Darkening or discoloration of wood components is typically not indicative of wood

decay. The affected area should be cleaned in accordance with the instructions in the Marvin Homeowners' Manual, and refinished with a fungicidal finish product to prevent further surface growth.

IN NO EVENT WILL MARVIN OR INTEGRITY BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES. IN NO EVENT WILL MARVIN'S OR INTEGRITY'S LIABILITY EXCEED THE PRICE PAID FOR THE AFFECTED PRODUCT OR COMPONENT.

The limitations of liability and disclaimers of warranty set forth herein shall survive and apply, even if the exclusive remedy is found to have failed of its essential purpose.

This Limited Warranty Supplement, together with the Marvin Limited Warranty and/or the Integrity Limited Warranty, is the only warranty, written or oral, express or implied, provided by Marvin or Integrity. No dealer, employee, or agent of Marvin or Integrity, nor any third party, may create or assume any other liability, obligation, or responsibility on behalf of Marvin or Integrity. ALL IMPLIED WARRANTIES, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE DISCLAIMED. Any implied warranty which cannot be disclaimed under applicable law will be limited in duration to the shortest permissible term and, in any event, will not exceed the term of the applicable express limited warranty; the requirements for presenting any claim so affected will be as provided in the Marvin Limited Warranty or the Integrity Limited Warranty, as applicable. Any product or component not specifically subject to this Limited Warranty supplement or another written Marvin or Integrity product warranty is provided AS IS and without warranty. THIS LIMITED WARRANTY SUPPLEMENT IS NOT A WARRANTY OF FUTURE PERFORMANCE OR A STATEMENT OF THE USEFUL LIFE OF ANY MARVIN OR INTEGRITY PRODUCT, BUT ONLY A WARRANTY TO REPAIR, REPLACE, OR REFUND.

LAW AND JURISDICTION

This Limited Warranty Supplement, and any Marvin or Integrity Limited Warranty amended hereby, are subject to the laws of England & Wales and both owner and Marvin or Integrity irrevocably submit to the non-exclusive jurisdiction of the English Courts in relation to any dispute arising out of or in connection with the same.
